Terms and Conditions of the Tahiti Tiare Program™

1. *Tahiti Tiare Program* membership and its benefits are offered at the sole discretion of Tahiti Tourisme North America (TTNA) and each of the foregoing entities' officers, directors, partners, and employees.
2. TTNA *Tahiti Tiare Program* Terms and Conditions are governed by and are to be construed by TTNA. The Program Terms and Conditions set forth here in supercede all prior Program Terms and Conditions.
3. TTNA reserves the right to dismiss any member from the *Tahiti Tiare Program*. The decision to dismiss any persons is final and prohibits the member(s) to attend any TTNA or affiliated function.
4. Membership in and application for membership in the TTNA *Tahiti Tiare Program* is void if prohibited by law in the country and/or State of the Member's or applicant's domicile.
5. The Program has no predetermined termination date and may continue until such time as TTNA decides to terminate the Tahiti Tiare Program, at any time, with or without notice.
6. TTNA reserves the right to add, modify, delete or otherwise change any of the rules, procedures, conditions, and benefits pertaining to the *Tahiti Tiare Program* at its sole discretion, with or without notice. This means that TTNA may make changes that affect, but are not limited to, members enrolled in the *Tahiti Tiare program*.
7. **Only Retail Travel Agents** may enroll in the *Tahiti Tiare Program* and become a *Tahiti Tiare Agent* (defined as retail travel agents who have been accepted as Members by TTNA and who have received *Tahiti Tiare Program* Terms and Conditions). TTNA will attempt to send correspondence to active Members to advise them of matters of interest, including notification of Program changes. 19. TTNA is not responsible, and assumes no liability, for changes or discountenances of program benefits and/or services.
20. The Program and any benefit, offering or the like relating to the Program, shall not be construed as or constitute a contract or otherwise establish a contractual relationship between TTNA and any *Tahiti Tiare* Member.

Your continued membership/enrollment in the *Tahiti Tiare Program* following the posting of changes to these terms will mean that you accept these changes.
